a) Discussion took place on the CBF membership crisis. Fewer than 50% of the Canadian ACBL members are paying CBF membership fees.

The following suggestions were made at the meeting:

- Unit web sites could post messages encouraging members to pay CBF dues. These could be links from the CBF website so that they all gave the same message.

- Need to have articles that emphasis the benefits of membership and stress where the membership money goes. Should especially highlight the fact that we now have a French web site.

b) Discussion took place on possible site for the CBF International Fund Regional.

- London was suggested as a possible site.

#### c) Discussion took place on the new screen proto-type.

- Most felt we do need better screens. In general people like the proto-type. A couple of concerns with the new screens were raised:

- not sure about the colour (white)

- feel screens should extent further out from the table

- d) Canadian Senior Championships
  - Discussion took place on the format of the CSTC
  - Suggestions were:

make first two days a Round Robin with no reduction in teams from Day 1 to Day 2
have pre-registration so we have a better idea on how many team would be taking part
