Nader Hanna, as CBF President, assumed the Chair and Janice Anderson, as Executive Secretary, was directed to act as Secretary of the meeting. **The Chairperson declared a quorum present and the meeting to be regularly constituted**.

1. CALL TO ORDER & AGENDA

At 8:35 a.m. the President called the meeting to order.

Nader outlined how he thought the CBF had a good year in 2011/2012 but we still have some major issues to face:

- we have set up the CNTC-C and have 12 teams registered to play this year
- we have set up the Mini-McKinney races and the first winners will be announced early in 2013
- the continuing decline in CBF memberships is still a major concern
- we have hit a dead end at trying to get recognized as an Amateur Athletic Association
- we have a new agreement with Osteoporosis Canada and will see how that works for awareness
- we need to continue working on our International status Nader outlined his progress on this so far
- Nader outlined how he would like to spend two or three hours brainstorming and discussing ways to increase and/or diversify membership. The board spent time the first morning of the meetings doing this.

2. CORPORATE MATTERS

2.1 CONFIRMATION OF ELECTIONS

Janice Anderson reported the following election results for 2011 elections. Nader Hanna - Zone III Term: ends December 31, 2014- re-elected by acclamation Peter Morse - Zone VI Term: ends December 31, 2014 - re-elected by acclamation

2.2 UPCOMING ELECTIONS

This fall, elections will be conducted in Zones I and IV. Nominations are being accepted until September 30, 2012. Both Kathie Macnab and Neil Kimelman indicated that they plan to seek re-election. Successful candidates will begin their term on January 1, 2013. A Call for Candidates will run in the August 2012 issue of Bridge Canada. Clubs in Zones I & IV will also receive information by mail. The Call for Candidates notice will also be placed on the CBF website.

2.3 ANNUAL GENERAL MEMBERSHIP MEETING

The 2011 meeting was held on May 28, 2011 in Regina, SK at the 2011 Canadian Bridge Championships. **The minutes of the 2011 AGM were reviewed by the Board**.

2012 AGM is set for here in Montreal - Saturday, May 5

Janice will put up posters announcing the meeting and will see what CBF board members are still available. If Nader is still in Montreal, he will chair.

It was decided to try holding the 2013 AGM on the Wednesday morning of the Canadian Championships as more people may be available to attend.

3. CBF BYLAWS

There are no pending Bylaw amendments at this time.

4. MINUTES OF THE 2011 - 2012 BOARD OF DIRECTORS MEETINGS

4.1 May 18 - 20, 2011 CBF Board Meeting in Regina, SK

MOTION 12-3: Email motions as presented in Appendix A of these minutes, are approved. MOVED by Jerry Mamer. SECONDED by Peter Morse. <u>CARRIED UNANIMOUSLY.</u>

4.3 Business Arising from the Minutes

All items will be addressed under their corresponding topic.

5. MEMBERSHIP

Membership numbers in 2011 and first four months of 2012 are about the same as the previous year with a slight continual decrease. Numbers indicate the following:

On April 1, 2012 there were 17,881 ACBL members in Canadian Units

In 2011: 6,219 people paid CBF membership fees with ACBL membership and 8,901 did not.

- 66 paid CBF membership directly to the CBF- over half of these were the result of them playing in CBC.
 Janice reported that only 5 CBF memberships were received as a result of our promotion where Club Manager, Directors and Teachers could sell CBF membership, minus the \$10 service fee, and keep 20% of membership as a finder's fee.
- Nader reported on the table he set up at the CBF Regional in Toronto. He had information printed and displayed. At the conclusion of the tournament nearly all material was still there and no one asked any questions about CBF membership and no one purchased membership.

6. BRIDGE CANADA

2011 we spent \$9,755 on three issues of Bridge Canada. All three issues were digital and only available on our website. All three issues were in French and English. Beginning with the Dec. 2011 issue we have hired a professional to set up the French issue so that it duplicates the English Issue. Francine and Denis Cimon are still doing all the translating and proofing for the French edition.

The board expressed its sincere thanks to our editor, Jude Goodwin and to Denis and Francine Cimon for their translating work.

The spring 2012 digital issue of Bridge Canada cost \$3,789.

Discussed an email from EBSCO Publishing who would like to obtain a license to our Bridge Canada content. It was felt that this would have no benefit to us and thus the CBF is not interested.

The CBF will look into copy writing Bridge Canada.

7. INTERNET

Reviewed the website and identified continuing concerns:

- French still need more French content and should have Bi-lingual sidebars
- CBC reporting is still a major concern we really need some way for the DIC to upload results directly. Janice reported that Doug Rankin would again be posting from Montreal after each round. The problem being that people do not read and expect Jude's tables to be completed immediately and do not look at what Doug posts

MOTION 12-4: Jude Goodwin be paid \$30 + HST per hour for 8 hours per month webmaster service. This agreement is for June 1, 2012 to May 31, 2013. MOVED by Peter Morse. SECONDED by Neil Kimelman. <u>CARRIED UNANIMOUSLY.</u>

- Discussed advertising on the website.
 - Peter Morse will update and send out to the board a proposed policy on advertising.
- Discussed improving the side bars
- Peter will have a face to face meeting with Jude and go over items that need updating or work
- All CBF Board members will share in checking the site for out of date or missing items. They will copy Janice on any items they find.

8. CBF STAC

The 2012 STAC was run under the new ACBL structure. Janice had them send an email (bi-lingual) to all Canadian club managers advertising the STAC. In January and early February Janice developed lists of clubs that hadn't signed up for the STAC yet and sent them email reminders.

We made \$15,034.63 on 2012 STAC. Table count held about the same at 3,198.5 tables

The CBF STAC always begins on the third Monday of February.

10. TROPHIES, SCREENS AND EQUIPMENT

10.1 Mini-Richmond Pins

- reviewed the suggested pins. All agree it must be larger should be at least double the size of the sample pin.
- *The bottom portion of the pin needs contrast so that it is easier to read.*
- It was decided to only award pins to the Zone winners in the 10 categories. Jan will prepare certificates to also give to the National winners.
- on the CBF website the home page should list the top person Nationally in each category each month with a link to complete list.

10.2 Trophies

Selected a trophy for the CNTC-C National Winners.

10.3 Screens

66 screens were shipped here to Montreal. They will be stored in the Montreal Bridge League storage place. Jean Castonguay will get screens to Toronto for 2013 CBC and then they will go back to Montreal. 66 screens are stored in Regina. They will be needed in Calgary for 2014 CBC.

10.4 Clocks

Two of the clocks donated by Gordon Campbell stopped working at the end of 2011 CBC. In Montreal we are using Unit 151 clocks. We will need to find a solution for clocks fo 2013. Even if we could fix the ones we have, the cost of shipping would be prohibitive.

Neil Kimelman, Nader Hanna and Janice Anderson will try looking into finding suitable alternative to our clocks. With clocks in place and with directors making time announcements, players should be well aware of the time remaining in matches.

11. CBF INTERNATIONAL FUND REGIONAL

- discussed Bridge Mates - the cost would be approximately \$100 per table plus the system. Shipping and handling costs would also be involved yearly. Unfortunately this is a luxury the CBF can not afford at this time.
- discussed having Daily Bulletins but again the cost does not seem to fit the worth. Also it is very difficult to get anyone to do all the work.

- discussed Vu-Graph and it was felt that we should be trying to broadcast even more matches than we are currently doing.

Slow Play - *Discussed and reviewed the current Slow Play policy.*

MOTION 12-9: Allocation for slow play will be split equally between the two teams when the director does not assign any blame to either team.

- Slow Play policy will be put in the General Conditions of Contest for CNTC, CWTC and CSTC and any separate National Final Conditions will just refer players to the General Conditions.

- Discussed Electronic Device policies.

MOTION 12-11: Effective immediately the following Electronic Device Policy is in effect:

1. The following policy applies to all Canadian Bridge Championship (CBC) events except for the Saturday Swiss Teams.

All electronic devices are excluded from the playing areas and adjacent areas during any session of play. This does not apply to health related equipment.

- 2. The restrictions above apply to all pairs, team members, captains, coaches, play recorders (except those designated by the CBF) and kibitzers and are in force throughout any actual playing session or segment of play.
- 3. A violation of any of the restrictions above will result in a disciplinary penalty of one full board (12 imps at that form of scoring) for the first offense. A second offense will result in disqualification from the event for the pair/team. Kibitzers violating this policy will be removed from the playing area for the remainder of the session.

MOVED by Neil Kimelman. SECONDED by Peter Morse. CARRIED UNANIMOUSLY.

18. CANADIAN OLYMPIC COMMITTEE

20. JUNIOR BRIDGE

20.1 Junior Fund Games

Reviewed the numbers for dollars raised by Junior Fund Games. During 2011 February ``Junior Month` clubs brought in \$6,778 - this is down \$781 from 2010 During the other months of the year when Junior Fund games may be held, clubs brought in \$3,837.50 which is down \$1,986.50 from 2010. This decrease is still a result of the change in policy ACBL that now limits the number of Junior Fund games a club may hold each month. Games at Sectionals in the Maritimes brought in \$92.00 which is down \$3.06 from 2010.

Received \$576.05 in donation - the largest was from a 50/50 draw a Halifax Sectional. Total 2011 revenue was \$11,343.31

20.2 2012 World Youth Team Championship

- We will have an under 25 and an under 20 team. The under 20 team will be very inexperienced.
- Teams will have to be ratified by email vote.

- no budget submitted but it was noted that airfares are at least \$1900 Toronto to Shanghai.
- the junior teams will be provided with the same uniforms as our Open, Women and Senior teams.

MOTION 12-14: Rock Shi Yan is approved as being a pre-approved NPC for Youth and Junior teams. MOVED by Jerry Mamer.

MOTION 12-15: Bryan Maksymetz is approved as the NPC of the Canadian youngster team and Rock Shi Yan is approved as the NPC of the Canadian youth team. MOVED by Jerry Mamer. SECONDED by Neil Kimelman. <u>CARRIED.</u>

MOTION 12-16: Members of our youth and youngster teams along with the NPCs will be given \$100 each to cover transfers and incidentals. The money will only be paid out once all other receipts/invoices have been received.

The CBF will cover all team member costs for airfare and visa costs. This will be paid out to individuals only after receipts have been received.

Janice will arrange that accommodation costs are paid directly in advance by the CBF. The entry fee is paid by the CBF to the WBF.

20.3 Future Plans - new ACBL motion

- beginning January 1, 2013 all Junior fund game money will go directly to ACBL.
- CBF must submit a yearly budget to ACBL for Junior Fund money. Budget due by previous summer.
- ACBL will fund our teams.

- Janice and Nader will handle submitting a budge for 2013 to the ACBL. If possible we will talk to Robert Hartman, ACBL CEO, when he is in Montreal about this.

20.4 Junior Manager Report

No Junior Manager report was received but Nader Hanna gave some details on what has been occurring.

- had 24 kids take part in on-line work
- Bryan Maksymetz has been working hard with the kids.
- Bryan is close to naming the teams
- Eric Kokish has been working with the kids assignments, reviewing play on BBO
- Bryan is planning a weekly newsletter
- Bryan has a Junior section on the CBF website

Discussed requirements of anyone involved with CBF Junior program.

All board members were asked to try and encourage Sectionals in their Zones to hold IF games .

The ACBL is planning to introduce a new fund, the Grassroots Fund, which will have a designated month. This will give one less month for International Fund club championship events and will also mean clubs have one more choice of funds to support. This will probably cause a decrease in International Fund revenue from games at clubs.

Janice reported that ACBL has changed the International Fund games at Sectionals. Previously a Sectional could upgrade one or two sessions to Regional rating if they made them International Fund games and submitted \$4 a table per session to the International Fund. Now a Sectional will be able to up grade one or two sessions by making them beneficiaries of any of the Funds (Charity, Junior, International or Grassroots). This will likely decrease our International Fund revenue even more.

21.2 2011 World Team Championship

- was held in Veldhoven, The Netherlands October 15 - 29, 2011

-NPC reports from the teams

- Senior Team did not send in a report within the allowed (60 days) time and thus forfeited \$1000 of their team subsidy

- no players submitted reports or comments

Nader Hanna reported on the new technology used at the 2011 World Team Championship

21.3 2012 Event

- World Bridge Games (formerly Olympiad) to be held as part of the 2nd World Mind Sport Games in Lille, France

- Canadian teams will be decided at the 2012 CBC here in Montreal

21.4 Future World Events

-2013 - World Team Championship - Bali, Indonesia Sept. 16 - 29, 2013 - must be preceded by a Bi-Country Playoff

-2014 undecided at this time - Poland was interested but do not have the funding, Berlin was interested but wanted it at the same time as the NABC dates.

- a town in Italy may be possibility as they have the funding.

21.5 Subsidies

-Current subsidy formula is: Each team receives - 1/3 of the subsidy pool plus the money raised in IF surtaxes in their event at the CBC. The entry fee is paid from the team's 1/3 share of the subsidy pool.

- It was noted that this year we will also have to provide each team with uniforms to comply with the WBF Dress Code.

MOTION 12-18: The 2012 Subsidy Pool will be \$40,600. Each team's entry fee will come out of their share of the subsidy pool. The CBF will pay for the team uniforms from a uniform budget. MOVED by Neil Kimelman. SECONDED by Peter Morse. <u>CARRIED UNANIMOUSLY.</u>

21.6 NPCs

Reviewed the applications received for people wishing to be included on the pre-approved NPC list. At this time no other names were added to the Pre-approved NPC list. Reviewed the CBF policy regarding NPC reports.

MOTION 12-19: Not submitting an NPC report may be grounds for removal from the pre-approved NPC list.

MOVED by Neil Kimelman. SECONDED by Peter Morse. CARRIED UNANIMOUSLY.

21.7 Uniforms

WBF policy now dictates that all teams must have team uniforms and no one will be allowed in the playing area if they are not in their team uniform. The board reviewed the submission from Brian Ferguson of Talbot Marketing Inc.

Board felt teams should have four tops - "polo" or golf style or shirts.

The board decided to give each member of the Canadian teams one shirt each of #2, #3, #4 and #5 on the Talbot sheet. This will apply to all teams - Open, Women's, Senior, Youth and Youngsters.

The budgeted cost will be \$125 per person plus we will have postage costs to distribute the shirts. This comes to approximately \$2,800 from the International Fund for the Open, Women's and Senior teams and \$1,900 from the Junior Fund for the Youth and Youngster teams.

21.8 WBF Eligibility

The WBF has ruled that our Canadian Bridge Championships are a zonal playoff and thus anyone taking part in our championships is now considered to have played in a Zonal playoff and under current regulations will be ineligible to play in another country's Zonal playoff or represent another country for 2.5 years. Janice will announce this at the Captain's meetings here in Montreal.

21.9 WBF Zone II representatives

Discussed the current way in which the WBF Zone II representatives are picked. The WBF has suggested that changes are coming in their Bylaws re: zonal representatives. It was felt this would be a good time to actually get a CBF selected representative on the WBF for Zone II.

Nader Hanna will continue his efforts on behalf of the CBF to get a CBF representative on the WBF board for Zone II.

22. CBF COORDINATOR AND OFFICE

Janice Anderson notified the CBF Board that she would like to retire after the conclusion of the 2014 Canadian Bridge Championships in Calgary. Janice left the meeting while discussions on this topic took place.

MOTION 12-20: Janice Anderson, CBF Executive Assistant, be given a \$1500 bonus in recognition of her work on behalf of the CBF during the past year. MOVED by Neil Kimelman. SECONDED by Peter Morse. <u>CARRIED.</u>

Each Zone Director will contact anyone they think might be interested and suitable to take over the job of Executive Assistant. Zone Directors can show individuals Jan's month by month job outline. Anyone interested should submit a resume to the CBF by fall of 2012.

Janice is asked to begin preparing a list of all items that will need changing - contacts, addresses, bank accounts, etc.

23. TRANSLATIONS

The Board extended its thanks and appreciation to Gerard Côté for his translation work and willingness to continue as the CBF translator.

Janice pointed out how helpful Gerard had been with translating emails from people with questions about these championships.

24. ERIN BERRY MEMORIAL FUND

The Trustees had \$4675 available to give in grants - this represented the interest earned in one year plus 5% of the principle. The following grants were made:

- John Carruthers will be stepping down as Chairman of the Canadian Bridge Hall of Fame committee. Paul Thurston will take over as chairman after the 2012 induction ceremony.

26. SPONSORSHIP/FUNDRAISING

26.1 Osteoporosis Canada Proposal

- the program, which is called Bridge Across Canada, has been set up and started in Toronto.
- reviewed contract with Osteoporosis Canada
- Benefits to the CBF are: visibility
 - bringing our name in front of potential sponsors
 - CBF gets 30% of any money from a title sponsor (minimum \$7500)

- CBF responsibilities are:

- Acknowledgement as a sponsor of the CBF and display of sponsor's logo on the CBF website and in Bridge Canada magazine
- Publicity and display of sponsor's logo at the two major annual CBF organized events, namely the Canadian Bridge Championships and the CBF International Fund Regional (posters, event publications and hand-outs, etc). The CBF shall also distribute any samples or promotional material provided by the sponsor to participants at these events.
- Where possible, sponsor acknowledgement in CBF related articles published in the ACBL's monthly Bulletin
- The CBF shall ask Canadian bridge columnists reporting on the Canadian Bridge Championships in national newspapers to acknowledge the sponsor.
- The CBF shall ask Canadian commentators to acknowledge the sponsor during any live internet broadcast of the Canadian Bridge Championships.

- The Board agreed that we should proceed with this agreement for the next 6 months and see how it works. We will review it at that time.

- The real hope is that this will help us in gaining some Corporate Sponsors.

_26.2 Instant Match Point Game

- Janice will notify the ACBL that we are not proceeding nationally with this game right now but we do want to keep the right to hold such a game.

26.3 Amateur Athletic Association

- our main reason for trying to get this designation was so we could actually issue tax receipts to people who made donations to us.

- Nader outlined the work done over the last one and a half years and all the paper work that was completed and submitted and how we appealed the original ruling. **Result: we have been denied this status.**

- This was denied because the Canada Revenue Agency ruled:

"Although the Applicant may operate on a nation-wide basis, it remains our view that bridge does not fall under the definition of amateur athletics for RCAAA purposes." The denial goes on to explain that they use a definition of "athletics" as "competitive activities requiring physical skill and endurance."

Nader outlined how, even though this failed, we need to work on approaching Government in regards to getting sponsorship.

It was suggested that we need to set up a Committee to work on this.

- to gather ideas
- to formulate how to lobby for government change
- to open doors
- try local Members of Parliament.

We need to think of what people we know who are politically connected. This topic will be raised at the AGM to see if we can get some people to help form a committee.
