Nader Hanna, as CBF President, assumed the Chair and Janice Anderson, as Executive Secretary, was directed to act as Secretary of the meeting. The Chairperson declared a quorum present and the meeting to be regularly constituted.

1. CALL TO ORDER & AGENDA

At 8:32 a.m. the President called the meeting to order. Nader extended a welcome to all. Nader introduced Ina Demme, the incoming Executive Assistant to the Board and welcomed her to the meeting.

Nader outlined how he thought the CBF had a good year in 2012/2013 but we still have some major issues to face:

- we had the first awards in the Mini-Richmond races and they were well received
- membership decline has slowed down by the number of Canadians who are paid up CBF members is still a major concern
- the agreement with Osteoporosis Canada did not lead to major sponsors we should end up getting \$3,000 from Pfizer as a result of this program
- we need to continue working on our International status and having a voice with the WBF since we are a NBO

2. CORPORATE MATTERS

2.1 CONFIRMATION OF ELECTIONS

Janice Anderson reported the following election results for 2012 elections.

Kathie Macnab - Zone I Term: ends December 31, 2015- re-elected by acclamation Neil Kimelman - Zone IV Term: ends December 31, 2015 - re-elected by acclamation

MOTION 13-1: The re-election of Kathie Macnab and Neil Kimelman are ratified by the Board.

CARRIED UNANIMOUSLY.

2.2 UPCOMING ELECTIONS

This fall, elections will be conducted in Zones II and V.

Nominations are being accepted until September 30, 2013.

Jerry Mamer indicated that he plans to seek re-election.

Successful candidates will begin their term on January 1, 2014. A Call for Candidates will run in the August 2013 issue of Bridge Canada. Clubs in Zones II & V will also receive information by mail. The Call for Candidates notice will also be placed on the CBF website.

2.3 ANNUAL GENERAL MEMBERSHIP MEETING

The 2012 meeting was held on May 5, 2012 in Montreal, QC at the 2012 Canadian Bridge Championships.

The minutes of the 2012 AGM were reviewed by the Board.

- Nader reported that no one had contacted him with sponsorship leads
- combining the CWTC and/or CSTC with the CNTC-A is not feasible for many reasons
- no interest in lowering masterpoint limits in CNTC-B & C at this time

2013 AGM is set for here in Toronto - Wednesday, May 29

Nader Hanna will chair the meeting.

Janice will put up posters announcing the meeting.

3. CBF BYLAWS

The new CBF Bylaw #1 was posted on the website at the end of April in order to give 30 day notice to the changes. The AGM will be asked to pass a motion ratifying the CBF Bylaw #1

Nader Hanna thanked Peter Morse for all his work on getting the new CBF Bylaw #1 ready.

MOTION 13-2: The CBF Board of Directors ratifies the new CBF Bylaw #1.

New "Not for Profit Act" - next steps:

- reviewed the forms that must be completed and sent in with the new CBF Bylaw #1.
- discussed how to liquidate the assets of the CBF should the organization dissolve this is needed for transition to new "Not for Profit Act"

MOTION 13-3: The CBF liquidation plan is:

- If funds exceed \$15 per paid up member, all funds will be divided equally to the paid up members of the CBF as of the date of dissolution
- If funds are less than \$15 per paid up member, all funds will be turned over to the CBF Charitable Foundation for distribution according to their criteria.

5. DISCUSSION ITEMS

The Board of Directors took time to discuss many items and considerations for the future.

- a) Membership
 - *Ideas on increasing memberships:*
 - idea of adding new types of members required funding but since we cannot offer Revenue Canada tax receipts, we ran into a road block for getting the needed donations
 - could utilize the website to give materials to paid up members recommendations for books, have skill tests that people pay a fee to take
 - approached Golf Clubs to see if they would sign up as a club and CBF would organize tournaments for them- they were not interested in this
 - ► *Need to continue with all efforts to find new sources of members*
- b) Sponsorship need to think of organizations that fit our demographics. With this in mind Nader Hanna spoke with Chartwell, a company that runs retirement residences. He talked to them about sponsoring an event. Things we can offer them are: name an event after them
 - banner on website
 - logo in publication and at events
 - offer to let them have an information booth at CBC
 - give them access to our membership thru our website, publication and events

What we would hope to get for this is \$25,000 annually.

MOTION 13-7: Nader Hanna is authorized to negotiate a sponsorship agreement with Chartwell Reit on behalf of the CBF.

Some other groups we could approach are: Drug companies, Pharmacy chains, Financial Investment companies

Options: - get one of 5 Zone 2 reps being selected by CBF

- look at joining another Zone

d) Commonwealth Games - 2014

Given that 2014 is an Open World Championship year, the board discussed making this event the prize for the CNTC-A winners in 2014

- e) Membership Fees
 - Is it time to raise fees?
 - Need to give more to paid up members member only section on website then could have magazine only available to paid up members
 - will hold off looking at a membership fee increase until we can provide more to paid up members

6. NEW EXECUTIVE ASSISTANT & TRANSITION PLAN

- Reviewed the transition plan and how we are progressing
- Reviewed what equipment is in Regina office and what Ina will need in her office

MOTION 13-8: All computer hardware and office equipment that exist in the Regina office on May 22, 2013 be written off in 2013 and 2014.

MOTION 13-9: Janice Anderson is authorized to purchase 34 sets of new age bridge boards with cards to be kept with the Western Screens.

CARRIED UNANIMOUSLY.

Discussion took place on where items may be stored in Western Canada. The board will need to ask around and see if there is a suitable place.

Janice Anderson reported that two of the time clocks that were donated to the CBF by Gordon Campbell have quit working. The third clock is likely to go at any time as well. The cost of shipping the clock is extremely high.

MOTION 13-10: Janice Anderson is authorized to dispose of the time clocks that are in Regina.

SECONDED by Kathie Macnab.

CARRIED UNANIMOUSLY.

At this point, Nader Hanna welcomed Leo Weniger, Claire Jones and Donald Mamula to the meeting. Nader especially thanked Don Manula, ACBL President, for taking the time to join our meetings.

7. MEMBERSHIP

Membership numbers in 2012 and first four months of 2013 are about the same as the previous year with a slight continual decrease. Numbers indicate the following:

On May 1, 2013 there were 18,355 ACBL members in Canadian Units

In 2012: 6,378 people paid CBF membership fees with ACBL membership and 8,707 did not.

75 paid CBF membership directly to the CBF- over half of these were the result of them playing in CBC.

► It was agreed that our membership promotion where we offered to drop the \$10 administration fee on memberships paid to club officials/teachers should now be considered over. There will be no more rebates to clubs collecting CBF memberships. This did not prove to be a way to increase memberships.

8. BRIDGE CANADA

2012 we spent \$13,800 on three digital issues of Bridge Canada.

The board expressed its sincere thanks to our editor, Jude Goodwin and to Denis and Francine Cimon for their translating work.

We need to run a disclaimer in each issue about the contents being the views of the authors. Need to set deadline for submitting material earlier so that the magazine can come out when planned.

Discussed how we decide on what articles we print and what we do not print.

MOTION 13-11: Neil Kimelman is appointed "Content Editor" of Bridge Canada and Jude Goodwin is appointed as "Production Editor" of Bridge Canada. The Content Editor will receive an honourarium of \$500 per issue. The Production Editor will be paid an hourly rate. **MOVED by Jerry Mamer.** SECONDED by Jean Castonguay.

CARRIED UNANIMOUSLY.

Neil Kimelman will set up Guidelines for determining what is published.

Janice Anderson will talk to Jude about these changes.

Francine and Denis Cimon will continue as French Editors.

MOTION 13-12: The French editors will be given an honourarium of \$500 per issue.

9. INTERNET

MOTION 13-13: Jude Goodwin be paid \$30 per hour for 8 hours per month webmaster service.

- Discussed advertising on the website. We do need to formalize an advertising policy.
 - Peter Morse will update and send out to the board a proposed policy on advertising.
- Discussed improving the side bars
- Peter will have a face to face meeting with Jude and go over items that need updating or work
- All CBF Board members will share in checking the site for out of date or missing items. They will copy Janice on any items they find.
- ▶ Discussed using "social media" to get people more aware of our website. On CBC page there should be a note asking people to like CBF on facebook.
- Would be good to have more links to blogs
- We do have a twitter account
- Discussed having a member only section

A sub-committee of Nader Hanna, Jerry Mamer and Kathie Macnab will look into expanding website development. They will identify what we all want and then how to proceed.

10. CBF STAC

We made \$15,988.81 on 2013 STAC. Table count was 3,299.5 tables - the largest to date.

The CBF STAC always begins on the third Monday of February. We have sanctions for 2014 & 2015.

2015 STAC - February 16 - 22, 2015

Janice reported she again had problems getting ACBL to send out emails about the STAC.

Janice reported on how a few clubs reported they would not hold any STACs in protest of the new ACBL regulation that playing directors are not eligible for overall awards.

Janice reported on the ACBL Board of Governors initiative to get a regulation passed by the ACBL that will allow STAC sponsors to stipulate that playing directors may place in overall awards.

MOTION 13-14: The CBF STAC will allow playing directors to be eligible for overall awards.

SECONDED by Jean Castonguay.

- Jean had to do a fair amount of repairs on the screens before bringing them to Toronto. He stressed how important it is that they are packed up correctly.

- Jean could not find good magnets Janice will talk to Cal McLeod and get some to send to Jean.
- The 66 screens in Regina will remain there until after the 2014 Canadian Championships.

c) Equipment

- two projectors were purchased to use with lap tops and the clock program.
- as discussed earlier Janice will dispose of the clocks stored in Regina.

d) Printer/Copier/Scanner

- Janice reported how the CBF printer/copier/scanner died while preparing for these meetings. Given that a new one would not be used as much in Regina, Janice purchased her own personal machine and is only asking that the CBF pay for any toner used while she is working for the CBF. **The Board agreed that this was totally fair.**

- It was suggested that Ina will need a better printer/copier/scanner. Janice suggested that she likes the one she purchased and it was very reasonably priced. It is a HP8100 all in one.

16. CANADIAN SENIOR TEAM CHAMPIONSHIP (CSTC)

- 2012 Montreal, QC 12 teams
- Winners: Joseph Silver, John Carruthers, John Guoba, Martin Kirr
- The Board reviewed the format and felt that the current format is the best we can do. The Board will have to develop plans on how to handle a large number of entrants.

12 teams - 11 matches - 10 or 11 boards

14 teams - 13 matches - 9 boards

16 teams - 15 matches - 8 boards

18 teams - 17 matches - 7 boards

- With pre-registration we could either add a day to the event or break into pools if the numbers were too large
- Janice will study past entrants and prepare statistics for the Board on how many of the participants in the Seniors had played in one of the other team events first.
- Discussed having pre-registration for future CSTCs.

The plan would be: Beginning with the 2014 CSTC, teams coming to play in the CSTC as their first event will be asked to pre-register with the non-refundable Round Robin entry fee. Participants in the other team events will be asked to register their intent to enter the seniors if eliminated from their other team event. Registering intent to play if eliminated will not require a non-refundable Round Robin entry fee.

- This will be mentioned at the AGM. The CBF Board will have to make a decision on this before September of this year.

18.3 Conditions of Contest

Conditions of Contest were reviewed by the Board.

Janice reminded the board of the email decision to forego, for this year only, the regulation that any team that enters the event knowing they have a member who is poisoned due to not being a continuously paid up CBF member since the previous January is poisoned. **Discussion took place on what to do in future years.**

MOTION 13-16: To be eligible to represent Canada Internationally, if a player's membership in the CBF has lapsed for a period of four (4) months or more, that player must have been a continuously paid up member of the CBF since January 1 of the previous year. The CBF Board of Directors may grant an exception in extra-ordinary circumstances. This provision shall not apply to first time members of the CBF. Determination of first time member status is at the sole discretion of the CBF Board of Directors. MOVED by Peter Morse.

SECONDED by Neil Kimelman.

CARRIED UNANIMOUSLY.

MOTION 13-17: Poisoning regulations are confirmed as being:

When a player is eligible to play in the CNTC but ineligible to represent Canada in the event for which the CNTC is to qualify a team, that player is said to be poisoned. An otherwise eligible team which knowingly begins play in the CNTC with one or more poisoned members may play in the CNTC but will be ineligible to represent Canada in the events for which any member is poisoned.

MOVED by Jerry Mamer.

SECONDED by Neil Kimelman.

CARRIED.

It was noted that these poisoning regulations apply to CNTC-A, CWTC and CSTC as well so all Conditions of Contest will need to be fixed up.

In the Conditions of Contest - section III.B. Poisoning should be combined with IV. G Eligibility to Represent Canada.

In the Conditions of Contest - III. Player Conditions: A: Eligibility and Entry: Remove: "Any player, that is not a paid up member of the CBF, arriving at the CNTC National Final, will only be allowed to play in the National final after payment of a \$200 penalty fee is received. This fee includes CBF membership for one year."

This is no longer needed since all players must be paid up CBF members before they can be listed on a team and the deadline for making changes to team members is at least 3 weeks in advance of the event.

MOTION 13-18: The prize for winning the 2014 CNTC-A will be subsidy to attend the 2014 Commonwealth Games Bridge Event in Glasgow, Scotland.
