1. CALL TO ORDER & AGENDA

At 8:49 a.m. the President called the meeting to order. Nader extended a welcome to all.

2. CORPORATE MATTERS

2.1 Confirmation of Elections

Ina Demme reported the following election results for 2015 elections.

- Kathie Macnab Zone I Term: ends December 31, 2018 re-elected by acclamation
- Neil Kimelman Zone IV Term: ends December 31, 2018 re-elected by acclamation

MOTION 16-1: The election of Kathie Macnab and Neil Kimelman are ratified by the Board.

MOVED by Nader Hanna SECONDED by André Chartrand <u>CARRIED UNANIMOUSLY.</u>

2.2 Upcoming Elections

- This fall elections will be conducted in Zones II and V.
- Nominations are being accepted until September 30, 2016.
- Jerry Mamer indicated that he plans to seek re-election and he may have someone interested in taking over in 3 years. André will check if anyone in his zone is interested.

2.3 Annual General Membership Meeting

- The 2015 meeting was held on May 27 and 28, 2015 in Montreal, QC at the 2015 Canadian Bridge Championships.
- The minutes of the 2015 AGM were reviewed by the Board.
- 2016 AGM is set for Toronto Sunday morning, April 22nd in the Heritage room

4. BUSINESS REVIEW

Nader provided an overview of major 2016 initiatives and led a discussion on some business strategies and priorities going forward. Some of the highlights are:

- Sponsorship update no new sponsor. We are investigating possibilities for next year's CBC

5. ACBL Update – Paul Janicki

- Cheating
 - cheating scandals are a high priority- prosecutions are difficult, and keep being postponed
 - H. Weinstein heading task force on cheating. Players will be able to report anonymously.
 Group of players in charge of system. Video cameras will be used to record tables.
 - o BBO to delay transmission of events so that less possibility of cheating.
 - WBF dragging feet on cheating. Not taking lead. Coughing Dr.s are in courts, tying up resources.
- Curbing spending acbl score plus lost money. Equipment outdated.
- Board composition committee there may be changes to how the ACBL is run. Proposal to get rid of current board made up of regional directors. There can be conflicts with respect to district vs ACBL. New board would be 9 people, elected by general population of ACBL. The feeling is that 25 board members is too many.
- No more players appeals committee, directors only. They will get peer input.
- We can make motions to be considered by ACBL board. cosmetic, if we are not there to discuss or defend, it will go nowhere.

6. WBF Update – Paul Janicki

- Representation –Zone 2 of WBF is America, 5 reps elected by ACBL board. Could be outside of board candidates. Now Howard Weinstein elected. Not organized by WBF bylaws. CBF, MBF, USBF are NBOs.
- Possible concession re representation, since CBF currently has no voice they will add CBF president to international committee. But no invitation yet.
- Upcoming Championships:
 - o Poland this year
 - o France security concerns next year. Lyons

7. International Matters

7.1 2015 Chennai Review- Cheating issues were high importance. Credentials committee uninvited polish pair. Brogeland investigation of Polish, Israeli pairs. Polish was just before championships. Monaco withdrew, Israel withdrew, they made decision themselves.

7.2 2016 Wroclaw, Poland –

- Entrants to National Pairs as many can enter as want to. Must be a member of the CBF.
- Mixed Teams one team per country. Deadline for entries is June 15. Team would be responsible for all expenses. If more than one if from same city, hold match. If more teams interested, then we will have selection committee. Eligibility rules should apply.

7.3 2020 Update –

- WBF requires \$300,000US cheque by hosting country. Niagara Falls would be a
 possible location. But 400k for the convention centre plus WBF payment, cost
 would be around 1 million. A major sponsor would be required. No revenue
 would come to organizing country. Maybe possible to run Regional alongside if
 space is large enough.
- In Montreal playing space was provided by the city and there was no WBF payment.

7.4 NPC List

- All persons on the list were updated and those no longer wishing to serve as captain were removed.
- Requests were received from Martin Hunter and Mike Kenny.

MOTION 16-3: To add Martin Hunter and Michael Kenny to the Non-playing Captains List.

MOVED by Neil Kimelman. SECONDED by Nader Hanna. CARRIED.

8. Canadian Bridge Championships

2015 Review – In Montreal additional events were added and match length increased. Quarter and Semi Final was 90 boards.

Eligibility Policy - Was reviewed and revised to take into account players new to the CBF.

Championship Committee – André Chartrand, Neil Kimelman, Nader Hanna, Ina Demme until Angela returns on Thursday.

Locations for 2018 – Kathie will look into Halifax. Other option is Montreal, St. Catharines.

Equipment – East screens are in Toronto, West screens with Cal MacLeod and one box in Edmonton.

- Claire will be invited to meeting, so may be able to bring screens.
- Investigate new screens. The old screens need repair, are heavy and have faults in operation.

Hospitality – Hospitality budget was discussed.

MOTION 16-4: To increase the hospitality budget to \$150 per pre-registered team plus \$6 per estimated table at Regional.

MOVED by Jerry Mamer. SECONDED by Neil Kimelman. <u>CARRIED.</u>

Number of Boards – Current guideline is 60 boards per day.

MOTION 16-5: That the number of boards played during the Round Robin is as close to 54 boards as possible.

MOVED by Jerry Mamer. SECONDED by Nader Hanna. <u>CARRIED.</u>

CWTC – Try our best to recover the CWTC entries being held by Edmonton District. There is a new president and new treasurer. Half of cost was \$550.

MOTION 16-6 : To offer pay half of the cost of carpet cleaning at the 2014 CWTC in Edmonton, of \$550. MOVED by Jerry Mamer . SECONDED by Nader Kimelman. CARRIED Unanimously.

9. Online Teams

- Based on last years' registration, offer open, womens, under 2500
- Set a match time that is the final time possible. No later play is allowed.
- Allow 8 players to facilitate scheduling.
- Cash prize only, no option for entry in CBC
- Nader Hanna is the coordinator for 2016/2017

10. Junior Program

- Bryan Maksymetz is managing under 25 program
- Under 20 we only have 2 players
- Guardians are required for under 18 years, they pay their flights, we pay accomodations
- Kids team had fundraising program, raised almost 10k

12. Bridge Canada

- Neil presented cost for 2015 and projections for 2016
- Articles are aimed at all levels
- In 2014 we spend \$11,000 and in 2015 \$27,000. We need to determine a number of pages and stick to it. The budget will be \$21,500 for 2016

13. Website

- Our webmaster, André Leclerc joined us by conference call
- Concern that our website is slow
- French website is coming along content translated, Membee content is not perfect if French is selected.
- Even though every page may not be perfect in French, the decision is to launch and fix as we go.

14. Better Bridge Presentation

- Audrey Gran and her team, made a presentation on a possible partnership plan
- There would be a teacher presentation as well as lessons for beginners and intermediate
- Teachers would spread the word about the CBF
- This would generate new CBF members
- Possibility of non-sanctioned games and CBF website has results of these games or list of winners.
- Non-sanctioned games could earn credits for CBF benefits like Audrey lessons.
- Kathie Macnab to coordinate with Better Bridge to arrange seminars.
- Locations will depend on Audrey's schedule.
- Registrants free CBF membership
- We would cover Audrey's expenses
- Start with trial in a couple locations and see how it goes.
