# 4. BUSINESS REVIEW

- Last year there were complaints at the CBC. The Championship Committee should be notified right away. The Committee should meet with the Director at the end of the tournament or get a written report.
- At the June conference call discuss the number of directors assigned to our tournaments.
- Hall of Fame committee Katie Thorpe is the new Chair, members are Michael Roche, Eric Kokish, Jim McAvoy, Karl Hicks, André Chartrand, Neil Kimelman
- Based on complaints we receive about CBC, the idea of having a players committee was
  discussed. However, consensus is very difficult in the short time we have to make decisions.
  Also, agreement may be difficult to achieve. Instead of a small group making decisions the
  whole Board should be involved.
- Board of Director issues during Conference Calls, suggestion is to go around the table to give
  everyone a chance to comment. Need to be better about responding to email motions. Maybe
  collect responses on Basecamp?
- Organizational Priorities we have only one employee, when we take on new projects, resources need to be considered. We need Board volunteers or contract workers to help get things done.
- Having a CBF credit card will help with accounting procedures.
- Possibly have CBF Points. A benefit of CBF membership. Points earned at CBC and CBF events. A possibility of a rating system. Maybe a partnership with FunBridge, they have a rating system.
- Dissatisfaction with ACBL is growing, what would it take to separate from ACBL?

## 5. BETTER BRIDGE PRESENTATION

- Audrey Grant and Dean joined the meeting
- We have done seminars in Saskatoon, Winnipeg, Calgary, Vancouver, Halifax, Moncton, Charlottetown, and upcoming in St. John's.
- Better Bridge partnership More to be discussed, maybe links on each others' sites.
- Audrey presented a video of her experiences in various locations. We will add it to our website.
- Audrey's concepts are short games 2 hours long, cleaning up clubs is important, no first to last list
- Ideas for partnership training for membership, each week post something new from Better Bridge on our website, digital subscription maybe Complimentary lesson online, 1 per member?
- Guidebook for how to run a multi-level social duplicate.
- Better Bridge invests small amounts to help bridge clubs. Giving new cards is a small thing to help clubs.

# Better Bridge - What next?

- Finish seminars in remaining provinces Ontario and Quebec
- Positive suggestions cleaning up the clubs is important
- Short games 2 hours works, longer games may not.
- Audrey suggestion that CBF provide leadership.
- No first to last, clean club, teacher training important.
- Give training program for membership program, each week something on our website but need better, magazine article ready to go, digital subscription. Complimentary lesson, online 1 per CBF member.
- Guidebook on how to run a multi level social duplicate. Teacher training online adobe direct.
   Live audio no video. Daily column
- Alternative product, 10 pages, description
- Better bridge teachers video
- Dean's help
- Invest small amount to help bridge clubs. Clean card program shipping over a period of 6 months, 3 doz or 4 dozen, clean cards, then the club responds how it helped
- Plastic cards much better.

#### 6. CANADIAN BRIDGE CHAMPIONSHIPS

# 6.1 - 2017 CBC Winnipeg

Championship Committee – André Chartrand, Neil Kimelman, Angela Fenton, Nader Hanna when in Winnipeg

Eligibility to represent Canada – Poisoning was discussed with respect to people who may have inadvertently not paid their CBF dues. It was decided not to make an exception based on these circumstances.

# 6.2 - 2018 CBC

- We currently do not have a location for 2018 and this may be an option to do something different. Especially since this is an open year where attendance tends to be smaller.
  - o Provincial playdowns maybe play online against teams in other cities.
  - o And we subsidize the provincial winners to come and play.
  - Work on something like this, maybe for 2022
- See if we can find a location in the next month, if not maybe hold on a smaller scale at a community centre or university

#### 7. WEBSITE

- Nader presented a tour of our membership management website.
- We may need to look for another webmaster depending on what happens to FQJR and what happens with André Leclerc

#### 8. DIRECTOR EXPENSES

- Travel for moving screens would be reimbursed
- Expenses for special events such as Audrey Grant seminar would be reimbursed.
- \$200 per year for miscellaneous expenses
- Mileage instead of airfare must be reasonable amount

#### 9. CONDITIONS OF CONTEST

- We received complaints when we considered removing the Quarter Final from CNTC A due to low attendance. Also complaints when we put back the QF.
- Should we try to end pre-supper? Or play to 8 or 9.
- Not possible to get player feedback during scheduling process, maybe set up an email for CBF complaint department or Suggestion/Feedback department
- ACBL and WBF have general Conditions of Contest and Specific where an event needs something additional. General will cover the number of teams and playoff structure. Board will review, Nader volunteers to draft, Ina to do initial review.
- The situation is happening more often that a team member has medical issues after registering. If sick, they can be replaced at any time by submitting request to the Board. If a team signs up and a team member gets sick, a refund (less processing fee) can be given.
- There is a large gap between the CNTC B and C prize money, \$2000 and \$600 respectively.

MOTION 17-6: That CNTC B and CNTC C prizes be changed to \$1,500 and 1,000 respectively.

# 10. ALZHEIMER EVENT – DAY OF BRIDGE BENEFITTING ALZHEIMER SOCIETIES

- Branding issue US Association won't allow use of Longest Day in Canada.
- CBF is working with ACBL and Azheimer Society to create event in Canada

# 11. ONLINE CHAMPIONSHIPS

 André suggested that we look into a CBF club on BBO for CBF members, where you can earn CBF points that could be used as a credit for CBF events. BBO would report points to us. • Online Championships – value vs problems is the issue. Jerry Mamer will be the co-ordinator of the online team league. Inappropriate behaviour will be subject to penalty. Jerry will draft rules. Registration deadline September 15<sup>th</sup>, start of league October 1<sup>st</sup>.

# 12. JUNIOR REPORT

- Some in the kids group are promoting bridge to peers. Two who are 15 are arranging bridge camps. Last time they raised just under 10k. Now parents want to pay expenses to send a kids team in addition to youth, and junior teams.
- A few from the kids group are now 15-20. Next time in China. So they are ready for under 20. We have 6 or 7 players who are 20-26 for the Under 26.
- We need new people for the program. How to find young people Nader talked to coordinators. Most know Nader is involved and let him know of possibilities.

#### 13. MEMBERSHIP BENEFITS

Bridge Canada – costs down this year. Send to membership. Leave article honorarium as is.

MOTION 17-7: To approve the budget for Bridge Canada of \$21,300 for 2017/2018.

  - Zoomer contacted us, as they were developing online bridge, half a million across
     Canada distribution. Proposal from them was very onesided, they wanted our list of members.
  - NABC CBF will have a booth. Give out copies of magazines, get convention card stickers with 50<sup>th</sup> anniversary logo, information about CBF events. Angela to coordinate the booth at NABC.

MOTION 17-8: That the CBF have a booth and give a \$2500 sponsorship to NABC, with an overall budget of \$4,000.

#### 14. CBF REGIONAL

- Regional this year in Kingston, ON
- 2018 will be St. Catharines, ON
- maybe offer Kingston 2019
- Split Regional is an idea
- ACBL is now allowing online sections for Regional. Some districts aren't letting them in.
- Saskatoon is a possibility, but costs are high
- Maybe look into community centres, universities

# **15. STAC**

- Down 200 tables but we still make money.\$
- 8 sanction fee.
- 3<sup>rd</sup> week of Feb.

#### **16. ROOKIE MASTER GAMES**

- The current definition of rookie as 0-50 masterpoints was discussed. Since the concept of the game is to introduce new players to duplicate, it was decided to keep this definition and not increase masterpoint level.
- We will try to have a French translation of the analysis to see if participation in Quebec will be increased with bilingual material.
- We will reduce the sanction fee to \$0 and see if this will increase participation.
- Maybe introduce a credit system for masters who participate.

MOTION 17-9: To eliminate the sanction fee from Rookie Master games.

# **18. ACBL UPDATE**

- New CEO search is ongoing, there are a few good candidates. Starting interviews.
- Robert Hartman finished at the end of July.
- 168,000 paid to WBF for all ACBL members that expenditure is being questioned. USBF contributed out of their money this year. This will be voted on at Toronto NABC
- No rezoning or redistricting at this time. looking at how the board has its meetings.
- Districts will stay the same, how board selected will be looked at. Maybe 10 instead of 25 board members. Where 1 board member has 2 districts. On hold pending new CEO
- Tournament director manager US regulation, change to hourly rate rather than session rate as employees.

#### 19. INTERNATIONAL MATTERS

- IOC rules state that each country needs to participate in zonal conference. WBF has told ACBL that
  they cannot be zonal authority. ACBL feels that if an NBO wants representation, they should pay.
  USBF has bigger problem, it has to maintain 140,000 members to have 2 teams in Bermuda bowl. In
  Kansas, Ken Monzingo and Bob Heller met with Nader to discuss. All went to USBF meeting with
  WBF reps. Bob Heller, head, USBF, CBF and ACBL how to make a zonal conference, what is ACBL
  role, what does it mean in terms of financials.
- Nader will continue to work on this.
- Canadian players get no WBF masterpoints. We are deemed to have come 4<sup>th</sup> or 5<sup>th</sup>. First 2 spots go to US.
- Wroclaw playing space adequate. Some problems with computers for submitting line ups and for score printing. Restaurants and hotels far away, players needed to use public transportation. WBF added mickey mouse events, making each event smaller. For example, Mixed pairs was 10 sessions of 10 boards, over 2.5 days. To qualify for semi - final, but a lot drop in. Then the final is 9 tables.
- Mexico playoff, June 10 and 11. They will have 3 teams this time. Our teams get \$5000 per team.
- World Championships are in Orlando in 2018
- If things do not work out with ACBL and USBF, or if Mexico leaves and we not longer get a 3<sup>rd</sup> spot we could join Central America zone 5. We would have to apply to WBF, but we have that option. We would need to playoff with them, for 2 teams from Central America, Mexico and Bermuda. There will be an increase in cost, to either host or to go there for playoff.

#### 20. LIFETIME ACHIEVEMENT AWARD

• Lifetime achievement award should be the "builder" type. And leave the Hall of Fame award for player achievements. This way we still recognize both categories.

MOTION 17-10: That Hall of Fame procedures be adjusted to remove the builder category and those people will be considered in the Lifetime Achievement Award.

MOVED by Nader Hanna. SECONDED by André Chartrand. CARRIED.

 Nomination form needed for Lifetime Achievement Award. We will create one based on the Hall of Fame form.

# 21. CBF OFFICE

- Obituaries will be posted on the CBF site if they are known across Canada.
- Non-Playing Captains list if a person from the list is picked nothing further needs to be done. If person not on the list is chosen, they should submit qualifications and the Board will consider the qualifications and ratify. We will post the names of people on the list, on our website and the list with qualifications will be sent to Captains of winning teams. \$1000 is held back from subsidy until report submitted, is an article for Bridge Canada a requirement?

MOTION 17-11: That Ina Demme, CBF Executive Assistant be given a bonus of \$2,000 in recognition of her work on behalf of the CBF during the past year.

MOTION 17-12: That Gary Westfall be appointed auditor for 2017.

MOVED by Neil Kimelman. SECONDED by Kathie Macnab. CARRIED.

# 22. COMMONWEALTH GAMES

- A few teams have approached us
- We will have an announcement on the CBF website deadline is the end of August to express interest in attending. We will tell Commonwealth that we will send team.
- If more than one is interested, we will have online playoff. Matches online, not funded.
- Uniforms we will provide uniforms. No choices, we will select the shirt, and provide 2 per person.

MOTION 17-13: To provide uniforms and entry fee, total up to \$1000. US.
