# 4.0 BUSINESS ARISING FROM THE MINUTES

## 4.1 2020 CHARITY COMMITMENTS

### 4.2 CHAIRMAN'S REPORT

- 1. The Foundation can only give to another charity in Canada. The Chair referred to the Guidelines as posted in our website. For the most part we stay away from Medical Charities as the amount of our donation has very little impact on the disease. Projects funded are of short time lines. We hope to receive recognition as the only way to promote the CBF. In Manitoba, they have been able to gift money to registered charities that support bridge programs. These may be a Seniors Centre or Seniors Activity Centre where our gifts are allocated to their bridge program run out of the Centre. In other words, 'help others help ourselves'.
- 2. There was a discussion regarding holding charity games on BBO that would benefit the CBFCF. April 12-18 is charity week. It is our expectation that the sanction fees paid by Canadian virtual clubs for those charity games will make their way back to the CBFCF. Once we have established that these charity monies will be coming back to Canada, Ina will put a banner on the CBF homepage encouraging participation in charity week. Cathy Walsh will advise the Trustees of the monies generated and returned to Canada through these charity games. Without these monies, the CBFCF will see very little revenue in 2021. There was also a discussion about holding a national charity championship. It was agreed that this would be discussed at the board meeting for the CBF. The Longest Day Alzheimer Week held in June seems to be well publicized and has gained support.
- 3. Education Foundation. The Chair had looked into the ACBL Education Foundation they have 401K charity status and wideranging objectives. The CBF may be able to set up something similar with the focus being on bridge instruction. The ACBL

would be happy to see Canada have their own Educational Foundation.

4. Planned Giving: The number of Charity games are dropping each year. The CBFCF would be able to issue a tax receipt for the donation. It was decided to defer a decision on how to handle Planned Giving to the CBF board meeting in May/June.

The Chair offered thanks to the Treasurer for reducing the bookkeeping fees from \$2,400 to \$1,000 as 2020 was atypical due to covid. The Chair also noted that the Treasurer should not suffer any loss incurred for the miscue on the donation payment.
