## 6.0 FOCUS ON FUNDING

There was a discussion on returning the focus on funding to helping organizations that improve the lives of seniors. Kathie Macnab noted that the CBFCF is looking to receive some recognition for these donations. Kathie also noted that when reading the list of donations given out in the year, she does not always see how they conform to the focus agreed upon for the year. Kathie noted that she has reached out to the clubs in her zone in an effort to find worthy seniors organizations for her donation allocation. With only \$1,500 available for each trustee, it may be more difficult to receive recognition for the CBFCF of the amount is split amongst two or more organizations.

## 7.0 OTHER BUSINESS

Charity sanction fees are decreasing. At this rate we will have difficulty meeting our expenses each year. Gim has proposed mailing a letter

encouraging the clubs to hold charity games as well as CBF sanctioned games. \$330 was set up in the budget for this initiative.

The CBFCF was established so that the money from charity games would stay in Canada, rather than going to the ACBL and then to American charities. With the CBFCF, proceeds from the Longest Day (eventually) come back to Canada. These funds are distributed back to the provincial Alzheimer associations based on the province in which the sanction fees were paid. Catherine Kinsella noted that many clubs are only back to one third or one half of the pre covid table counts. Also, there are many new club managers since covid.

Sending out a mailer to the clubs to encourage charity games would be helpful.

Kathie Macnab suggested that we find a charity that supports seniors across Canada, and organize a cross Canada game. Kathie Macnab and Cathy Walsh will work on this together.

## 8.0 APPOINTMENTS
