In consideration of the Releasees or CBF's acceptance of my son/daughter's entry in the above event, I hereby freely agree to make the following contractual representations and agreements.

I acknowledge that bridge is not an inherently dangerous sport, but fully realize there are dangers associated with participating in a bridge tournament and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example and not limitation, the dangers arising from transportation to the bridge tournament, THE RELEASEES' OWN NEGLIGENCE, and the possibility of physical and/or mental trauma arising from the competition.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO INDEMNIFY AND NOT TO SUE the Releasees and the sponsors of this event, the organizer and any promoting organizations, property owners, law enforcement agencies, all public entities, special districts and properties, and their respective agents, officials, and employees through or by which the events will be held, (the foregoing are also collectively deemed to be Releasees), FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my son/daughter's participation in, or association with, the event, or travel to or return from the event.

I agree it is my sole responsibility to be familiar with the Releasees' rules, and any special regulations for the event. My son/daughter has no physical or medical condition that to my knowledge, would endanger my son/daughter or others if he/she participates in this event, or would interfere with his/her ability to participate in this event. I understand that drug testing may be conducted for participants registered for this event and that the use of substances prohibited by Releasees rules would make my

son/daughter subject to penalties including, but not limited to, disqualification and suspension. I agree he/she to be subject to drug testing if selected and its penalties if he/she fail to comply with the testing or is found positive for the use of a banned substance.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert my claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for wilfully and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to any other provision herein or as a consent to any subsequent waiver or modification.

Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
